Flood Risk Management: Insights without borders

Exchanges of experiences and research between the US and its international partners can provide insights to improve flood risk management worldwide.

The comments of the communication researcher Lera Boroditsky, made in another context, also apply to the mission of ASFPM's International Committee: "The opportunity to work with others around the world who come from other perspectives gives us a chance to enrich our own understanding, to build a more sophisticated and complex representation of the problem. The richer our understanding, the closer we can get to a good set of solutions. So, it's important to remember that good communication is not just about getting others to understand your perspective, but also allowing yourself to listen and learn and enrich your own understanding in the process." The NFIP provides the framework for Flood Risk Management (FRM) in the US. While the

NFIP has provided much needed assistance to communities and individuals impacted by disasters, we are all familiar with its shortcomings. Over the last 20 years there has been a great deal of discussion about how to "reform" the NFIP and more generally, FRM in the US. The International Committee believes that by connecting our members with colleagues in other countries, we can shape the conversation in the US by exposing our members to solutions from other contexts. At the same time, we can expose other countries to what has worked well in the US. We encourage you to engage in our discussions, webcasts, and conferences, and let us know how we can more effectively create a productive trans-national dialogue.

In a nutshell

What is the ASFPM International Committee?

A platform to exchange knowledge at a global level, and to discuss the best practices on the wise use of floodplains in order to reduce flood losses, manage water resources, and promote sustainability in the built and natural environment.



ASFPM Conference

ASFPM's 43rd Annual Conference in Cleveland, Ohio May 19-23, 2019

International Policy Discussion Session

Webinar 2. Flood risk management in the US: Local and state government examples

Chad Berginnis, ASFPM Executive Director, Anna Serra-Llobet, University of California Berkeley and ASFPM International Committee co-chair, October 10, 2019

Chad Berginnis and Anna Serra-Llobet were invited to participate in the first webinar exchange with the EU, talking about examples of flood risk management in the US. The webinar was organized by Ioannis Kavvadas, from the European Commission's Working Group on Floods, Water Unit of the Directorate-General for Environment, in collaboration with the International Water Office in Paris.

Webinar 3. Puerto Rico's hurricane Maria recovery process through integrated flood risk management

Juan González-Moscoso, Relmagina Puerto Rico October 30, 2019

In this webinar, Juan González-Moscoso explained how Puerto Rico is undergoing the recovery process after hurricane Maria devastated the island in 2017, resulting in the loss of 3000 lives. He made emphasis on integrated flood risk management as a key element for sustainable solutions. This webinar was moderated by Alejandro Riano, the Latin America and Caribbean regional coordinator.

Workshops

This last year we have also collaborated with different universities from Canada and Europe to organize the following workshops:

Workshop 1. Regulatory flood mapping systems in Canada, the US and France: Emerging trends

Institute of International Studies, University of California Berkeley, June 19, 2019

In this workshop we compared the Flood Insurance Rate Maps with the equivalents in Quebec and France. We learned about technical differences in the methods and models used to create them but also about the implications of these regulatory flood maps on land use planning, insurance and emergency management. This workshop was organized by Anna Serra-Llobet, University of California Berkeley, and Thomas Buffin-Belanger Université du Québec à Rimouski. Workshop 2. Innovations in river management in Germany and the US: Integrating ecosystem restoration into flood risk management

Institute of International Studies, University of California Berkeley, 17 October 2019

In both North America and Europe some of the best opportunities for river and floodplain ecosystem restoration are tight to projects that holistically manage flood risk. Due to different institutional arrangements and policies, the way we do that in both regions is very different. In this workshop we highlighted elements that can be implemented across borders. Workshop 3. From epic wildfires to epic flash floods: Rethinking flood risk management in an era of extremes

Institute of International Studies, University of California Berkeley, February 5, 2020

With the increasing extent of wildfire across North America, the risk of flash flood and debris flows is increasing, posing threats to urban areas. In this workshop we discussed ongoing efforts in the US (mostly California) and the EU (mostly France) to manage flash floods after wildfires and explore opportunities to better understand flood risk and improve its management by looking at the problem from multiple disciplines.
